All dogs must be well socialised, obedient, quiet, well behaved, house toilet trained and must not suffer from separation anxiety. A 24 hour trial stay for your dog will be expected by KozyK9z in advance of your main booking, for the benefit of both parties and your dog/s

Please Read
It is important you read the following details

Confirmed bookings are taken with a 50% deposit of the total boarding fee, payable within 48 hours by cash or bank transfer. Should payment not be received within 48 hours of booking, the booking will be cancelled and the space offered to another Client. The remaining balance of the boarding fee will be required upon the arrival date of your dog.

Boarding Charges From:

£30 Day Care Monday to Sunday, includes walk/s – Half day 4.5hrs at £18

£30 Overnight Monday to Friday, including walk/s

£40 Day Care Bank Holidays, £45 Overnight Bank Holidays

Christmas and New Year period upon request (24th December to 2nd January)

Opening hours 8am to 5.30pm

Client drop and collection times are between 7.45/8.30am, 11.30/12.30pm and 4.30/5.30pm

Collection & drop by Kozyk9z charges are £5 each way depending on distance

Clients drop off & collection 'Out of Hours' has a charge of £5 per hour

Cancellation by Client - Please note that deposits are non-refundable once confirmed, the balance remaining when paid upfront will receive a refund as follows;

Cancellation up one month in advance 50% of balance cost will apply

Cancellation up to two weeks in advance 75% of balance cost will apply

Cancellation up to one week in advance 100% of balance cost will apply

Cancellation by Kozyk9z - In the unlikely event that we are unable to complete a confirmed booking for any reason we will refund your booking deposit in full and without any liability whatsoever or obligation to provide you with alternative care or boarding.

Each individual dog must have its own Health and Liability insurance and a photocopy of the policy will be required.

Dogs must be fully vaccinated against Canine Distemper, Infectious Canine Hepatitis and Canine Parvovirus and other relevant diseases. The course of vaccination must have been completed at least four weeks before the first date of boarding or in accordance with manufacturer instructions. Dogs cannot be boarded unless up to date vaccination records have been seen and photocopied for our records. Worming and flea treatments should also be up to date.

We also advise that your dog be vaccinated for Kennel Cough as we cannot be held responsible if your dog develops Kennel Cough during its stay with us. Should your dog contract Kennel Cough while in our care it will not be possible to socialise it with any other dog for the remainder of the stay. We also reserve the right to seek veterinary advice and administer medicine, should it be required.

Please ensure your dog has a collar and contact name tag as this is a legal requirement. In accordance with our licence conditions your dog will wear a tag with our contact details for the duration the stay with us.

You can bring your dog's bed or blanket and a favourite toy. This may help them settle more quickly. However, whilst great care will be taken with your dog's belongings, we cannot be held responsible for any damage to your belongings during their stay with us. Food bowls are not necessary.

You can provide their regular food to cover their stay with us. We can provide food, but this will incur an additional cost of £2.50 per day.

Your dog will be exercised within a group of no more than 6 dog's and will only be walked off lead where written consent has been granted. Only on condition they have good recall and without any liability to KozyK9z and/or any of their helpers.

Dog's must be fully house trained, well behaved, well socialised, quiet and obedient.

We reserve the right to crate your dog if they show any unacceptable behaviour during their stay with us.

Whilst every care is taken to make your dog's stay a safe and enjoyable one, you should note that dogs are left at their owner's risk and no responsibility can be accepted for illness, injury or loss through theft or straying, or demise of the dog.

The owner of the dog must accept liability for any damage caused by the dog to the boarding venue.
