In the unlikely event that we should have to cancel a booking this will be done on the morning of the arranged walk by 8.00am or as soon as possible via the contact telephone numbers provided by the customer.

I/we hereby agree that I/we the undersigned give consent for Heidi of Kozyk9z to walk my/our dog/s and provide Pet Services from time to time as requested.

In the event of an emergency and if Heidi is unable to make contact, with either myself or the emergency contacts which have been provided, I/we give permission for Heidi to seek veterinary treatment should it be required while my pets are in their care and I/we accept liability for payment of any veterinary expenses that may be incurred.

I/we also accept full liability for any loss, damage or unacceptable behaviour caused by my Dog/s whilst being walked or visited in my/our home and I/we also accept liability for payment of any public liability insurance excess incurred by either Kozyk9z. I/we have entrusted a key/s to Heidi to my/our property which is to be used only as agreed and the key/s will be returned on my/our request.

Please note that off lead exercise is only provided to those dogs whose owners have agreed/requested to do so above and who also signed below. By indicating 'off lead' and signing below you are agreeing to allow us to exercise your dog off lead in areas we deem to be safe. Please note that whilst every care will be taken whilst exercising your dog, ALL dogs exercised by Kozyk9z are done so at their owner's risk and no responsibility can be accepted for sickness, injury, loss through theft or straying or demise of the dog. Further-more no responsibility can be accepted by Kozyk9z for any injury or loss caused to any third parties or their belongings by the behaviour of a dog in our care. Please note that should your dog require veterinary attention whilst in our care we will do our best to have your pet seen by your regular veterinary practice, however in the event of an emergency it may be necessary to use another vet. Any costs incurred at any practice will be the responsibility of the owner and not that of Kozyk9z and full reimbursement will be required by means of cleared funds before or upon collection of the pet. Please also note that a 1 week's trial period will be undertaken to ensure that your dog/s show sociable behaviour with our existing clients, if how-ever this trial period should fail then we reserve the right to discontinue our Service with immediate effect.
